BYLAW #008-16

A Bylaw of the City of Chestermere, in the Province of Alberta, to amend Bylaw 020-14, being the Water Bylaw amendment.

**WHEREAS** The Municipal Government Act, RSA 2000, C. M-26 and amendments thereto provides that a Municipal Council may issue a Bylaw to provide the terms, conditions, rates and charges for the supply and use of utility services provided by Chestermere Utilities Incorporated in the City of Chestermere.

**AND WHEREAS** Council deems it desirable to amend Bylaw 020-14;

**NOW THEREFORE**, The Council of the City of Chestermere, duly assembled, enacts as follows:


1. That Schedule "B" to Bylaw 020-14 is hereby repealed and replaced with Schedule "B" attached hereto.
2. That this Bylaw comes into effect February 18, 2016 and is executed in accordance with Section 213(3) of the Municipal Government Act.
3. This Bylaw comes into full force and takes effect on the date of third and final reading.

**SCHEDULE "B"**  
**RATES, FEES AND**  
**CHARGES**

**Residential Water Service**

The following rates and charges apply to all residential dwelling Customers in the City of Chestermere.

<b>Fixed Monthly Service Charge</b>	\$22.26
<b>Fixed Monthly Lifecycle Fund</b> Effective Jan 1, 2015 to Dec 31, 2018	\$3.56

<b>Consumption Charge</b>	0m <sup>3</sup> - 18.0 m <sup>3</sup>	\$1.06 per m <sup>3</sup>
	Over 18.0 m <sup>3</sup>	\$2.13 per m <sup>3</sup>

**Non-Residential Water Service**

The following rates and charges apply to all commercial, industrial and institutional Customers within the City of Chestermere:

<b>Fixed Monthly Service Charge</b>	\$62.30
<b>Fixed Monthly Lifecycle Fund</b> Effective Jan 1, 2015 to Dec 31, 2018	\$7.18

<b>Consumption Charge</b>	0m <sup>3</sup> - 100 m <sup>3</sup>	\$1.33 per m <sup>3</sup>
	Over +100.0 m <sup>3</sup>	\$2.13 per m <sup>3</sup>

**Bulk Water**

The following rates and charges apply:

<b>Basic Charge</b>	\$5.10 per day, minimum 3 day
---------------------	-------------------------------

<b>Consumption Charge</b>	\$2.40 per m <sup>3</sup>
---------------------------	---------------------------

The use of water for flushing water mains, hydrant leads and water services connections

in order to clean and disinfect them shall be metered and the rate shall be \$2.40 per cubic meter.
