BYLAW No. 020-14**

A Bylaw of the Town of Chestermere to amend Bylaw 025-13, being a bylaw to provide for the terms, conditions, rates and charges for the supply and use of water services provided by Chestermere Utilities Incorporated in the Town of Chestermere.

WHEREAS it is deemed expedient and proper pursuant to the *Municipal Government Act*, being Chapter M-26.1 of the revised Statutes of Alberta and amendments thereto, that Council shall issue a Bylaw to provide the terms, conditions, rates and charges for the supply and use of utility services provided by Chestermere Utilities Incorporated in the Town of Chestermere.

NOW THEREFORE the Municipal Council of the Town of Chestermere, Alberta, duly assembled, hereby enacts as follows:


1. That Schedule "B" to Bylaw No. 025-13 is hereby repealed and replaced with Schedule "B" attached hereto.

**SCHEDULE "B"
RATES, FEES AND CHARGES**

Residential Water Service

The following rates and charges apply to all residential dwelling Customers in the Town of Chestermere.

Fixed Monthly Service Charge	\$19.36
Fixed Monthly Lifecycle Fund Effective Jan. 1, 2015 to Dec. 31, 2018	\$3.56

Consumption Charge	0 m ³ – 18.0 m ³	\$0.92 per m ³
	Over 18.0 m ³	\$1.85 m ³

Non-Residential Water Service

The following rates and charges apply to all commercial, industrial and institutional Customers within the Town of Chestermere:

Fixed Monthly Service Charge	\$54.17
Fixed Monthly Lifecycle Fund Effective Jan. 1, 2015 to Dec. 31, 2018	\$7.18

Consumption Charge	0 m ³ – 100.0 m ³	\$1.16 per m ³
	Over 100.0 m ³	\$1.85 m ³

Bulk Water

The following rates and charges apply:

Basic Charge	\$5.10 per day, minimum 3 days
---------------------	--------------------------------

Consumption Charge	\$2.08 per m ³
---------------------------	---------------------------

The use of water for flushing water mains, hydrant leads and water service connections in order to clean and disinfect them shall be metered and the rate shall be \$1.90 per cubic meter.
